A ***non-refundable deposit** of 50% of the total cost of services will be required upon booking your appointments and securing the date. This can be paid in cash or with a credit card.

BRIDAL CANCELLATION POLICY: Please be advised that cancellations or modifications must be made no later than 7 days prior to the day of the wedding. Failure to cancel within that period will result in the forfeit of the entire deposit, PLUS an additional 18% gratuity.

After this information is submitted we will schedule all the necessary appointments. Then you will be sent a Letter of Confirmation that will provide you with the finalized schedule. The schedule clarifies who each of your bridal party attendants are scheduled with and their specific appointment time.

THE TRIAL: Trial appointments are essential for the bride for both hair and makeup. This gives your stylist an idea of the look you are trying to achieve on your big day. We recommend that a trial appointment be made for hair and makeup no later than one month prior to your wedding day. In order to secure your wedding date, you have 5 business days following your trial to pay your first 50% deposit. If we do not receive your deposit during that time, your date will be released. Please call to book your trial at your earliest convenience.

SPECIAL INSTRUCTIONS FOR THE BRIDE AND BRIDAL PARTY:

- Please shampoo your hair the day before your scheduled appointment. If you need to be shampooed and blown dry or if you arrive with damp hair, additional fees may be added.
- Please arrive on time. In order to ensure you receive the service you deserve and stylists finish within the allotted time, it is important that you are punctual. Typically we run on a tight schedule. We do not want to have to rush to finish on your wedding day.
- Be sure to wear a shirt that is easily removed, preferably a button down.
- Please remove all traces of makeup and arrive with a clean moisturized face. It is not the responsibility of the makeup artist to cleanse your face.
- Arrive to the appointment with an idea of the look you would like our stylist or makeup artist to achieve. Photos are preferable. If you need ideas, check out our website or try Pinterest.
- Be sure to bring all accessories you need for you hair: tiara, veil, headband, flowers, etc.

IMPORTANT INFORMATION: We reserve our stylists exclusively for your bridal party; therefore we collect a 50% non-refundable deposit due no later than 5 days after your trial. The remaining 50% balance will be due no later than 14 days prior to your wedding day. Since you will probably have a lot going on, we will send you a friendly reminder one week before the due date.
